This totaled 407 acres of new habitat planted by the end of May 2018. The average application for projects is 8.7 acres in size. \$30,000 was spent on habitat seed provided to landowners.

The Bee & Butterfly Habitat Fund staff provided technical guidance on the establishment of pollinator habitat to private landowners, public land managers, solar power farm developers, corporations, beekeeping groups and universities.
