The program has established 287 projects on 3,523.4 acre of habitat as of July 2019. \$82,635 was spent on habitat seed provided to landowners.

The Bee & Butterfly Habitat Fund staff provided technical guidance on the design, establishment and management of pollinator habitat to private landowners, public land managers, solar power farm developers, corporations, beekeeping groups and universities.
